PhD SCHOLARSHIPS FOR **CLINICIAN RESEARCHERS**

Objective:

To recognise and develop clinician researchers of SingHealth Duke-NUS Academic Medical Centre (AMC) to support the growth of research capabilities in priority areas of our AMC and contribute to ground-breaking discoveries.

INTRODUCTION

- 1. The SingHealth Duke-NUS PhD Scholarships for Clinician Researchers are for clinician researchers within our AMC who are interested in pursuing a research-related PhD programme to advance their research career.
- 2. The Call for Applications is open to all clinician staff of SingHealth (doctors, nurses and allied health professionals) who are planning to apply for research-related PhD programme in a local university in 2023.
- 3. The PhD Scholarship will fund tuition fees of the clinician's formal PhD programme at a local university, over a 4-year duration. Local universities providing research-related PhD programmes include the following:
 - **Duke-NUS Medical School PhD Programmes**
 - National University of Singapore (Yong Loo Lin School of Medicine, Saw Swee Hock School of Public Health, etc)
 - Nanyang Technological University (Lee Kong Chian School of Medicine)
- 4. Applicants are required to apply for a formal PhD programme (at any local universities stated above) concurrently with NMRC Research Training Fellowship (RTF) and SingHealth Duke-NUS PhD Scholarships.
- 5. In-Principle Approval of Scholarships will be announced prior to the release of PhD admission results and scholarship funding will be awarded contingent on two rounds of NMRC RTF applications.
- 6. Manpower FTE support will be provided by the clinician's primary institution for a 4-year duration. (Standard bond terms apply for each PhD Scholarship awardee.)

ELIGIBILITY CRITERIA (at the point of application)

- 1. Applicant should be a qualified medical doctor / dental specialist registered with the Singapore Medical Council (SMC) / Dental Specialist Accreditation Board (DSAB) respectively, and employed to perform clinical duties in a SingHealth institution.
- 2. SingHealth Residents who are in their final year of residency and are keen in pursuing a PhD programme are eligible to apply for the PhD Scholarships. The candidate must be supported by the potential employing SingHealth institution and the ACP with which the applicant will be associated, upon successful exit from their Residency Training Programmes. Non-final year Residents who wish to apply may submit their applications, and the applications will be assessed on a case-by-case basis.
- 3. Nursing or Allied Health Professionals, who perform clinical duties and aspire to advance in a research career working on human clinical research or research related to biomedical sciences with potential health impact,

may apply for the PhD Scholarships.

- 4. Applicant must hold a primary appointment in a SingHealth institution and must remain employed in the institution during and throughout the PhD Scholarship's funding duration. Residents employed by Ministry of Health (MOH) must be supported as per clause 2 above.
- 5. Application to Duke-NUS Medical School PhD Programme is encouraged. For PhD programme not within Duke-NUS, applicants are required to provide reason for the proposed PhD programme. **Overseas PhD programme will not be eligible for the PhD Scholarships application**.
- 6. Each applicant must enrol into Duke-NUS Centre for Clinician Scientist Development's (CCSD) Individual Development Plan (IDP) at least one year before PhD application, for discussion on project career advice about PhD programme. This clause will be waived for the 2023 Call for Applications as this is the first year of the programme.

APPLICATION REQUIREMENT & EVALUATION CRITERIA

- 1. Each application must be applied using:
 - a) **Application Form** (to be completed by applicant)
 - b) Research Write-Up and Applicant CV (to be completed by applicant and discussed with Research Supervisor and Mentor)
 - c) **Supervisor and Mentor template** (to be completed by Research Supervisor and Mentor)

 The research supervisor provides advice and guidance on applicant's research career. The research mentor provides guidance and mentoring for the applicant's project and research domain.
 - d) **Nomination Form** (to be completed and endorsed by Clinical HOD, ACP Chair and SDDC Head (where applicable))

If ACP has more than one applicant, each application should be accompanied by the complete set of forms listed above.

- 2. All application(s) must be completed using the prescribed templates. Applications that fail to comply with requirements in any of the templates and / or incomplete applications will be disqualified and will not be reviewed.
- 3. All sections in the Application Form have to be filled in, unless stated otherwise; applicant is required to elaborate on their plans to develop capabilities within SingHealth and beyond, and describe how the research project aligns with the goals of Academic Medicine.
- 4. Applicant must provide a research project title, details of the proposed local PhD programme and research proposal, a write-up on their research focus, justification on how the proposed PhD training will enable he / she to pursue a clinician researcher career, as well as future plans in the research career.
- 5. Applicant has to name an **appointed research supervisor and mentor** to provide guidance during the course of the PhD programme and beyond. **Description of how the research supervisor and mentor will be able to advance the applicant's career in research** is required in the Supervisor and Mentor template. Additionally, each supervisor/mentor has to submit a **two-page CV** and **one-page letter of support** for the applicant.
- 6. Each application must be **supported by** the applicant's **Clinical HOD**, **ACP Chair** and **SDDC Head** (where applicable). Clinical HOD is to provide a **statement of support** for the applicant to undertake his / her PhD programme and ensure that the applicant is provided **appropriate support and protected time** to work on

the PhD related work.

- 7. These documents and data therein will be used for the purpose to review, evaluate, recommend, and approve the PhD Scholarships for Clinician Researchers award. They shall also subsequently be used to facilitate administration, talent management and development within the SingHealth Duke-NUS AMC.
- 8. Applications will be assessed based on the following criteria:
 - **Suitability of applicant** (aptitude, skill sets, public service ethos, publications and research track record, developmental and career plans)
 - Research proposal (clearly defined research topic, quality of science and potential outcomes in the
 respective research areas, focus on national research priority areas & areas of strategic importance
 to SingHealth Duke-NUS AMC)
 - Training environment (proposed PhD programme, Supervisor/Mentor and mentorship plans)
 - Applicant's research and practice environment (support from primary institution and ACP)
- 9. For shortlisted applicants, a short interview with the review panel may be required. Details concerning the interview will be disseminated once it is finalised.
- 10. For successful applicants, progress of the research project will be monitored during and after the Scholarship funding period. Applicants are expected to submit the reports periodically during and upon completion of funding period. These reports will be timed with the key milestone reports of the respective PhD programmes with the goal to provide oversight whilst not leading to excessive reporting.
