

FELLOWSHIP PROGRAMME (FCFP(S))

It has been a tiring journey, but one filled with many valuable lessons and newly built relationships. I have found deeper meaning in the work that I do, and a greater appreciation of the work being done by other Family Physicians in Singapore.

The FCFP(S) was the most challenging examination I had in my professional life, for it tested the competency of candidates in multiple domains.

The FCFP(S) journey rekindled my interest in evidence-based medicine and its critical appraisal. As a novice researcher, it made me realise the painstaking effort that goes into a well-crafted review article and research project. As someone who loves to teach, I got to learn the science behind effective teaching, and the art of preparation of behind-the-scenes materials. As a clinician, the clinical formative assessment and write-ups compelled me to think deeply about the way I manage complex patients and navigate around ethical dilemmas.

Through FCFP(S)' trial by fire, I emerged as a more well-rounded practitioner, and a better person. It taught me that it is possible to dream, overcome the sporadic temptations to give up, and attain success through hard work and deliberate practice.

GRADUATE DIPLOMA IN FAMILY MEDICINE (GDFM) PROGRAMME

I began working in Tampines Polyclinic in January 2015, and finding Family Medicine to be a great fit for me, I started the GDFM programme later that year.

Working in SHP has given me the advantage of easy access to the electronic hospital records that I fully utilise in managing patients. SHARING OF LEARNING EXPERIENCES

FAMILY MEDICINE RESIDENCY PROGRAM

I joined SingHealth Family Medicine Residency as a Core Faculty in July 2015. It has given me the opportunity to be exposed to new teaching methods e.g. team-based learning, flipped classroom. I find the use of outcome-based approaches to education more effective as they are more learner-centric. I also like the program's assessment framework, which enables us (preceptors) to give prompt and direct feedback to the learners.

Pedagogy is a bi-directional process that benefits both the learner and teacher. The additional perspectives that I get from my residents have often broadened my own understanding of certain issues. Overall, my journey with Family Medicine Residency has been an enriching and enjoyable one.



Not just in terms of medical content and approaches, but the patient demographic, the psychosocial component that each of them brings with their primary medical complaint, and the multifaceted dimensions of care that Family Medicine encompasses, in order to achieve optimal care for the society – community care, primary care, home care, transitional care, etc.

POPULATION HEALTH RESEARCH AND TESTING NEW MODELS OF INTEGRATING CARE DELIVERY

Dr Low Lian Leng is an aspiring clinician scientist with a deep interest in health services research, a path very rarely travelled by Family Physicians.

He is currently involved in several major research initiatives – the evaluation of new models of integrated care delivery; the SingHealth Regional Health System (RHS) Population Database; and a data analytics and population segmentation project in the SingHealth Population Health Centre Grant. The findings will drive service planning for the RHS, and generate insights on population segments and care delivery, improving population health outcomes and management in Singapore and globally. He has publications arising from two randomised controlled trials on integrated care models and predictive analytics.

Complementing his research work, Dr Low is currently the Director, SingHealth Office of Regional Health, SGH Campus. He is also working with the Policy Research and Economics Office in MOH, to develop a population health dashboard for the RHS.



FM ACP SEED GRANT

The FM ACP Seed Grant helps to support research projects that require modest levels of funding to generate preliminary data, in order to apply for a larger grant. Applications are open to faculty and fellowship trainees in FM ACP institutions throughout the year, from 1 January 2018 to 31 August 2019.

The project should be relevant to the following research focus areas of FM ACP:

- i. Health services & outcomes research
- ii. Health promotion & preventive care research
- iii. Innovations in primary care




STUDY TRIP TO DUKE HEALTH

FM ACP FORUM

FM ACP held its inaugural forum to review its mission and vision, and set some directions and plans to pave the way forward.





6TH ASIA PACIFIC PRIMARY CARE RESEARCH CONFERENCE (APPCRC) IN CONJUNCTION WITH FAMILY MEDICINE SYMPOSIUM

The conference was co-organised by FM ACP and the College of Family Physicians Singapore, with the theme "Advancing Best Care through Education and Research". The Guest-of-Honour was Assoc Prof Kenneth Mak, Deputy Director of Medical Services (Health Services Group), MOH, Singapore. The event attracted about 400 attendees from Asia Pacific.

APPCRC showcased the latest developments in education, research and clinical care across public and private primary care sectors in Singapore and the Asia Pacific. The Asia Pacific Academic Primary Care Research Group was also inaugurated at this conference to strengthen the development of Family Medicine across the region. Eminent local and overseas speakers shared invaluable knowledge and insights which greatly benefitted the delegates.





FAMILY MEDICINE HEALTH-I-HACKATHON (FMHH) 2018

The inaugural FMHIH attracted nine teams from seven academic institutions. The event is a platform for non-healthcare partners to brainstorm solutions to increase the uptake of hand hygiene practices in primary care settings.

FMHIH has proven its potential to identify innovative solutions to primary care issues and encourage more collaborations between the healthcare and non-medical disciplines. It also showcases technologies which can be adapted for healthcare applications.

The Family Medicine (FM) Review Clinic is a collaboration between the SKH FM Team and IMH senior management that was started in January 2017. The outpatient appointments of acute and long-stay inpatients in IMH are reviewed by the FM team. Due to the comprehensive generalist background of the FM team, they are able to consolidate and take over the management of many of the specialist outpatient appointments, especially in the medical specialties. This has led to a significant 38% reduction of multiple potential visits to specialist outpatient clinics in restructured hospitals.

The SKH FM Team also provides in-house training and continuous professional education for doctors, and regular weekly teaching sessions for Advanced Practice Nurses in IMH. They also manage inpatients in the wards, especially on general medical and palliative issues, thus cutting down on preventable readmissions to restructured hospitals.

A NEW MODEL OF SHARED CARE FOR LONG-TERM CANCER SURVIVORS

With more cancer survivors and longer lifespans among them, it is imperative that community-based care plays a prominent role. Dr Rose Fok Wai Yee from DFM, SKH hopes to pilot a new model of shared care in which Family Physicians focus on health promotion and optimal management of co-morbidities, while oncologists monitor cancer recurrence and toxicities, coordinated by a case manager and supported by a multi-disciplinary team.

Dr Fok's research indicates that Family Physicians can do this important work, and oncologists have concurred. Her research aims to further address operational issues of this pilot project. She hopes to eventually engage Family Medicine colleagues located in north-east Singapore, and expand the project to benefit more patients.

ACUPUNCTURE SERVICE IN FAMILY MEDICINE - A 2-IN-1 APPROACH

When Dr Richard Tan Tiong Heng joined SKH as a Principal Resident Physician in DFM, he was encouraged by Dr Farhad Fakhrudin Vasanwala, the Head of Department, to start an acupuncture service, primarily to provide complementary treatment for chronic medical conditions for inpatients and outpatients with pain-related musculoskeletal conditions, stroke rehabilitation, and other conditions such as male sexual dysfunction and weight management.

The acupuncture service in Family Medicine offers patients a 2-in-1 approach, in which they obtain primary care and traditional acupuncture treatment by the same Family Physician, who is also a certified acupuncturist.



BVH'S INTEGRATED PRIMARY CARE FOR AT RISK ELDERLY (IPCARE)

BVH piloted IPCARE in May 2017, combining the organising principles of the patient-centred medical home and transitional care (TC). IPCARE recruits general practitioners (GPs) in the community around BVH to take over the primary care of TC patients. BVH continues to support these GPs with case management and multidisciplinary care support. IPCARE is the proof of concept of a new and sustainable model of primary care that will meet the needs of elderly patients with complex medical and social care needs. It can also be easily replicated by community hospitals with a network of empowered GPs in the community.



CONTINUITY CARE CLINIC - FROM OUTPATIENT CLINICS TO PRIMARY CARE

With the continual rise of chronic diseases and a rapidly ageing population, patients increasingly receive clinical care from multiple specialists in acute hospitals.

The Continuity Care Clinic (CCC) was formed in 2014 by Family Physicians from the Care and Health Integration Department, CGH. The CCC aims to consolidate patient care, reduce the need for multiple specialty appointments and the risks associated with poly-pharmacy, and lighten the healthcare burden of patients and their caregivers. The Clinic balances specialty care in the hospital – delivering care to patients who require consolidation and navigation back to their primary care doctors. They also act as clinical champions to link up the specialists and general practitioners.



COMMUNITIES OF CARE

Family Physicians from FMCC, SGH, under the auspices of the SGH Office of Integrated Care, form transitional care teams which comprise of nurses, medical social workers and therapists. They are organised to work closely with the community health and social care providers in Chinatown, Bukit Merah, Tiong Bahru, Bukit Ho Swee and Telok Blangah. This model of care called "Communities of Care" had been validated by research to show significant reductions in hospital readmissions.

Similar Communities of Care have been created across the SingHealth Regional Health System. True to the principles and philosophy of Family Medicine, Family Physicians who run this service provide comprehensive and continuing care to patients in the community.



CONTINUING COMMUNITY CARE HOSPITAL TO COMMUNITY INITIATIVES

In line with a rapidly ageing population, increasing life expectancies and the need to make healthcare sustainable, there is an emphasis on shifting care from hospital to community, with the aim of maintaining good health.

The Continuing Community Care Department from CGH, St. Andrew's Community Hospital and SHP have been collaborating to provide holistic initiatives to ensure seamless handover of patient care from hospital to the community. Family doctors lead and support the safe transition of patients to the community, where long-term home care partners, polyclinics and the GP network provide continuing medical care.



PRESCRIPTION IN LOCKER BOX (PILBOX)

The PILBOX is a breakthrough self-service model of collecting medication at locker boxes instead of over the pharmacy counter. The initiative improves patient satisfaction and experience by making the collection of medication simpler, faster and more convenient, using self-service technology and innovation. PILBOX@Bedok Polyclinic, the first self-cooling medication collection locker system in Singapore, also expands the range of medications that can be self-collected. The PILBOX is envisaged to eventually support "Telemedicine" and subsequent medication delivery to patients.



MYHEALTH KIOSK

MyHealth Kiosk was developed to optimise healthcare resources and improve staff productivity in the polyclinics under SHP.

MyHealth Kiosk, the first of its kind in Singapore, records vital signs along with a pre-consultation medical questionnaire, and presents the collected information to the doctor during consultation. The clinical information acquired at the kiosk is also transferred to the Electronic Medical Record system. Since its launch in July 2017, more than 14,000 patients have used the kiosk, and feedback has been positive. These kiosks can potentially be deployed to all remaining polyclinics in SHP.

COMMUNITY ENGAGEMENT THROUGH | PATIENT SEGMENTATION AND GEOSPATIAL MAPPING

SHP aims to have an organisational structure that supports community engagement by defining population and community through patient segmentation and geospatial mapping. It can then better understand the needs of the community, work with social care and community agencies to reach out to patients, and make healthcare more accessible to them.

SHP has established collaboration with at least two social care and community partners, for most of the polyclinics to better coordinate care for these patients.

RIGHT-SITING: HOSPITAL TO SHP FAMILY PHYSICIAN CLINIC (FPC)

To improve care coordination and transition across the care continuum, SHP has piloted a workflow that directs discharged hypoglycaemic patients from the restructured hospitals to SHP FPC.

Having post-discharge review right-sited to FPC is beneficial to patients as the Family Physicians are able to comprehensively review all the issues that may have arisen during hospitalisation, and address factors contributing to the hypoglycaemia episode, which could reduce the risk of readmission for hypoglycaemia.

DIRECT ACCESS TO ADVANCED DIAGNOSTICS

The specialties of Cardiology, Gastroenterology and Orthopaedic Surgery have been seeing rising referral volumes and waiting time issues. Under MOH's "Regional Approach to Standardising Polyclinic Referral Protocol" framework, referral process and appropriateness will be reviewed and streamlined. SHP Family Physicians will be empowered to investigate and manage more patients at the primary care level through appropriate access to advanced diagnostics and therapeutics.

Direct access protocols and workflows for these three specialties have been established and implemented in partnering polyclinics and hospitals, and across the three public healthcare clusters. As a result, patient care can be more streamlined and better managed at primary care, providing greater convenience and lower costs to patients.

SHP CARE TRANSFORMATION (SCT)

SHP has embarked on care transformation journey to meet the changing and growing medical needs of its patients. The two key concepts of SCT involve (1) leveraging the scale and efficiency of large systems, aided by information technology, and (2) forming and maintaining the relationships in 'teamlets' for collective ownership of patients. Together, it is envisioned that these will lead to better operational efficiency, patient outcomes, and staff satisfaction.
