Reflections for 2020 & Looking Ahead in 2021

As we come to the end of an eventful 2020, we asked our Family Medicine Academic Clinical Programme (FM ACP) leaders and faculty for their reflections and what they look ahead for in 2021.

Call of Duty .. Family Medicine's crucial role

We have all been called to duty when the COVID-19 pandemic set upon us early in the year 2020, facing a definite infection threat but knowing very little at the initial and beginning. There was fear, reminiscent of SARS in 2004, but this time we were better prepared, stockpiled Personal Protective Equipment (PPE) as foundation safety measures, as well as established Disease Outbreak SOPs to guide our quick responses.

As Family Physicians, we face the uncomfortable reality that the usual cough and fever, by the numbers that we typically see, may yet be the potential new infectious disease. We face challenges in remodeling our care and roles, in our Polyclinics and Community Hospitals (kudos to Bright Vision Hospital for the excellent and timely conversion to a dedicated COVID-19 inpatient facility).

Ultimately, we faced our fears, bravely... served and protected our patients and committed ourselves to the National effort especially the Dormitory Support operations. However, it held the first-ever virtual graduation ceremony on 27 November 2020 to commemorate the successful completion of the Residents' training during a difficult year. It was a memorable occasion and created a sense of community in a time of social isolation.

MMed Preparatory Workshop (3 October 2020) & GDFM Preparatory Workshop (28 November 2020)

This was a challenging year for Education Department, SHP, for the preparation of both workshops.

126 candidates registered for the 9 allocated interview sessions


