

# Fellowship in Patient Safety & Quality (FPSQ)

## **PROGRAMME OVERVIEW**

The IPSQ FPSQ Programme aims to attract healthcare professional and researchers from the region and globally for a 6 to maximum 12 months of fellowship.

Interested applicants who are leading quality, safety and clinical improvement efforts or have strong interest in PSQ work can apply. Applicants will participate in relevant projects, committees and workgroups as matched to their assigned projects/ areas of interest. Each FPSQ Research Fellow will be assigned to a mentor.

#### **EXPECTED OUTCOMES**

Fellows will:

- Engage in approapriate methodologies and tools in the design, testing, and evaluation of solutions for their area of interest/ projects.
- Interact with PSQ leaders from local healthcare institutions.
- Produce a report or publication relating to their area of interest in PSQ.
- Share learnings at appropriate PSQ forums.

### **LOCATION & DURATION**

6 to maximum of 12 months (inclusive of a minimum 2-week onsite posting to IPSQ, Singapore)

### **PROGRAMME FEE**

Self-funding only.

Teaching fee wil be waived if the fellow is engaged in a IPSQ related project.

## **AWARD OF CERTIFICATE**

Certificate of Fellowship Attachment will be awarded to FPSQ Fellows who have successfully completed the programme requirements.

# **APPLICATION DETAILS REQUIRED**

Applicable only for applicants who will not be engaging in direct patient care during onsite fellowship.

Please note that applicants must be a healthcare professional, fully employed at a healthcare organization or academic institution. Applicants will be screened on the basis of their career goals and on the support and recommendation from their organization leadership or head of department.

Your application must include the following details:

- 1. Completion of Application Form (refer to form below)
- 2. Your current CV
- 3. At least 1 Letter of Support from your organisation leadership or Head of Department (HoD)

Interviews will be conducted for applicants to share their projects/ areas of interest and applications with the fellowship director. The number of FPSQ per year is subjected to a limit and may vary each year. Interviews will be conducted for shortlisted applicants to share their projects/ areas of interest and applications with the fellowship director.

Successful applicants will be issued an award letter. IPSQ FPSQ Research Fellows are to complete vaccination for COVID-19, Tdap and MMR before programme commencement.
